## **President's Update**

- Held all interviews and concluded hiring
  - o The VP of Operations and I have concluded interviews and have hired a Speaker, Secretary, CRO, VP Athletics and Director Finance so congratulations on being hired! I plan on having a meeting with these individuals to discuss their position so I will be reaching out to these people within the week.
- VP Social and Director Social Position
  - The VP of Operations and I have concluded the interviews for all positions. I'm sure you've noticed we haven't hired a VP of Social. We have read all the candidate's resumes, and cover letters and have interviewed every candidate that applied for this position. We have determined that they are not necessarily equipped to take on the role of VP Social as it requires a lot of planning and basic knowledge of New College. As you may know, in an inperson year it is their job to plan a trip to Montreal or Blue Mountain, a trip to Niagara and a Formal event. During the interviews we found that the candidates didn't meet the requirements that we had set. The VP Social's focus is planning large events and we have found that all the applicants had little to no planning experience, therefore the position remains vacant. However, the current Director of Social has expressed interest in the position, and we believe that she would be the ideal candidate for the position of VP of Social since she was on council last year and has experience with planning events and more specifically planning council events. We would rather have someone more experienced as VP Social and hire someone else for Director Social because of the workload and the importance of the position. The VP of Operations and I simply want what is in the best interest of the council and the constituents and we believe this is the best thing. Therefore, she has resigned from her position as director of social to attain the VP Social position. This emergency meeting is simply to accept her resignation and next meeting, we will be motioning to appoint her as VP of Social.
  - We are following the constitutional guidelines set forth in articles 9.8 which touches upon the appointment of a council member, 9.7 which is the resignation of a council member and 10.1-line f which states that all members of the council shall not hold more than one position related to council.
    - As per article 9.8 in the constitution, if a position is vacant for any reason, a person who meets the qualifications set forth in article 9.4 and who is approved by a simple majority vote may fill that position.
- Director Social Hiring
  - After this motion, Maria would have resigned from the position of Director social so we will now be hiring for that position. I will be getting in touch with the candidates that applied for VP Social, I will outline the job duties for director social and let them know that we will be hiring for that position to see if that is something they would be interested in. As well we will be posting the hiring on the listsery and our Instagram.
