Department Updates

President's Update

- Signing authority updates
 - Maritza Mohammed
 - "The VP Operations, VP Finance and I, went last Tuesday so we are all on the account now. This is just a reminder for reimbursements and fronting the cost, as executives we can't front the cost for a lot of things just because of our audit. We do it for our website or our accounts that our linked to our emails but besides that when it comes to your own events or whatever you would like to buy, try to front the cost or ask a constituent to front the cost. Just remember we must motion for it. After that we would reimburse you after the event or after the day the payment is in."
- Election Plans
 - Maritza Mohammed
 - "I had a meeting with the CRO last week and we went over the elections so right now we will be making many changes to make it work for an online environment seeing as fall elections will be online. We are also trying to make it less of a popularity contest to make it fair so rather than voting for them because you like them you would vote because of what they can bring to the table and their cause. We are adding one thing in which you will have to say a speech, why you're doing the position and your goals if you do get the position. Within the next few meetings, we will have motions to amend the By-Laws to add those changes in."





- General Member changes
 - Maritza Mohammed
 - "In this meeting today, I would like to change the General Members back to Social Representative and Athletic Representative. I spoke with the people that were General Members last year and I've spoken with Athletics and Social. They all seem to like the idea of changing it back to Representatives seeing as you would get to focus on one department rather than focusing on all four departments. When they focus on all four departments of Council, General Members are all over the place and they don't get the most out of their position so we will be switching it back later in this meeting."

Frosh sales

- Maritza Mohammed
 - "Frosh registration is currently up, it is on our website, but they do have to go through YU Start to register and it will be taking them to a registration link. Right now, we have about 30 or 40 people that have registered so far."
- End of Summer Reviews
 - Maritza Mohammed
 - "We will be starting to do end of summer reviews. The VP Operations and I will set up meetings the second week of August. In the meeting, we will go over what you've done, see if you're prepared for fall, if you had any questions about your position and to give you feed back on how you've been doing so far."
- Instagram takeovers
 - Maritza Mohammed
 - "The VP Promo mentioned it in the last meeting, but we are going to do Instagram takeovers. Right now, it's going to be myself and the O-Chairs before frosh but then after that it's going to be the rest of the positions so VP Promo will be contacting you on when your dates are scheduled. As for filming, you can start filming it now and have it prepared, you don't have to film it the week before it's due. I would say do it at least 2 weeks before it's due just so that they have time to edit it. If you're doing something like going to a cottage or you're doing something fun, try to film it in vlog style."
- Frosh Merch Order
 - o Maritza Mohammed
 - "We put in our frosh merch order, so everything is getting ready to be produced. We're getting t-shirts, our jerseys, bandanas, lanyards, laptop stickers and a baseball cap."

Orientation Chair Update

- Connected the hosts and guest speakers for the "Meet Your Major" event

 - "For this event, we will have someone from all the different streams to be host for each of the sessions. We are also getting speakers who have already graduated from the program to talk about their experience both with York and real life."

- "Instead of doing how we usually do with the teams, which is the team with the most points gets their team name on the belt. Seeing as this year is a little different, we're going to be distributing prizes to the froshies who show up the most and participate the most. For example, every time they come to an event, they'll get a point. We were thinking of doing an air pods giveaway, if it works with the budget, for the best froshie kind of like a froshie of the year award. Although that idea isn't set in stone yet. We were planning on having both external and internal forces for the froshies to want to go to frosh. This would be the external force for them to participate in this year's frosh."

 - "We are fine tuning the agenda, so each of the leaders participating in each event know exactly what they are doing, and we know exactly how many leaders we need for each event."

- Zumba, Yoga and Move-A-Thon with Tait are cancelled. Will have a Zumba Party and Yoga session using Youtube Video's.
 - Josh Raghurai
 - "Initially we we're going to do those events with Tait but we decided that we will no longer be doing those events because of certain things that have happened with them. We're trying to make a movement and support some other colleges with this decision. We will be replacing this with a Party and if we do decide to do the Yoga and Zumba it will be with someone that we choose or if we can find someone outside of York who is willing to do it for free"
- We will be doing a run through for all the presentation type events during the week of Aug 16
 - Victoria Hanna
 - "We will be working on run throughs for all the presentations because this is new for everyone. We are going to try to schedule everyone who is scheduled to do a real presentation during frosh for them to get use to the Bounce app. To ensure everyone knows what they are doing and if any problems occur in the setup call, we can hopefully solve them before the real thing."

College Head Update

- YOD Breakdown
 - Maritza Mohammed
 - "For York Orientation Day, I just wanted to give you all a breakdown of what the college head office is doing. It's going to be similar as the in person YOD. We will all be in one zoom call and the breakdown is going to be presentations and clubs as well there's going to be the council presentation. After that they will put us in breakout rooms which is where they will need a lot of our leaders. In those breakout rooms, it's going to be all the different programs and different streams so for that it would be Kahoots, games and presentations about your programs. After that we'd go back and there will be more presentations to fill them in on clubs. There will most likely be a professor speaking as well."
- Paid Peer Mentor Update

 - "As for peer mentorship, for the summer due to COVID they decided to do a paid and volunteer peer mentor positions. As of last week, they cancelled the paid peer mentors so there will only be volunteer peer mentors. This affects us, seeing as the paid ones were going to be the ones helping Council because they are getting paid. Now we probably won't have as much help because they are volunteering and a lot of the time, they will be taken by the College Head office."

 - "As for New Beat Articles, the New Beat Editor just wanted to give you a reminder that you do need to write an article. Right now, due to COVID it's hard to get people to write articles so make sure you're handing them in. I know the VP Athletics and the O-Chairs wrote one for this month so start preparing for September. The due dates for them are on the 12th of every month so that's the deadline for them."

- 7. Shall represent the Vice President Social at the Vice President Social Roundtable (SAYU) in case him/her or the Director Social cannot attend;
- 8. Shall, prior to the completion of his/her period of tenure, submit a written report to the Vice President Operations outlining the events along with recommendations for the consideration of the succeeding Council to be passed at the last Council Meeting in April;
- 9. Shall assist the NCC in the defining and achievement of its goals, in the best interests of the community, and shall engage in other such duties as may from time to time be assigned to him/her by the NCC;
- 10. Shall take a proactive role in all NCC matters;
