President’s Update

- Reforming By-Laws + what’s next
 - Maritza Mohammed
 - “I finally finished reformatting the By-Laws, now it’s much easier to read. We are going to vote on that later in the meeting. Once we’re done confirming the format, there are a couple changes that I would like to make or amendments I want to make for the By-Laws. One thing that I’ve mentioned before is changing general members back to social rep and athletic rep. As well, I’m going to start working with the CRO to make changes for the election process so it can fit online but also to make it less of a popularity contest so those motions are going to be coming up in the next few meetings because I want to get it done before fall elections and I want to get it done before hiring as well.”
- Signing authority update

- “The execs and I have been informed that we can finally change our signing authority to the 3 execs. Again, there’s going to be a motion about the guidelines of signing authority and how reimbursements are going to work. Once the motion passes we’re going to try and go to the bank this week but after that it’s going to be myself, the VP Finance and VP operations on the account.”

 - “For frosh we needed help with the jersey’s so the past VP promo, Adam Chan. We’re going to hire him on behalf of NCC and we’re going to be paying him, I believe it’s going to be \$150 or \$200 but that will be coming out of the exec budget.”

 - “We have had some suggestions for the council poster and the manager of LAPS wanted something to look more uniform. It wasn’t anything wrong that we did or that y’all did. They just wanted pictures that look more uniform so we’re going to be re-doing the council poster. Y’all will just have to take a picture with a black shirt and a white background. If you want, we might add a new college logo to it but just keep your clothes all black and take a headshot. The VP promo or the director promo will give you more information on that.”

Orientation Chair Update



- Victoria Hanna
 - “I hope everyone is excited for frosh, we’ve been working tirelessly to make sure everything is going smoothly. We have our frosh schedule made and at 9am we have our daily challenges, those are not going to be an event where you must wake up at 9am to participate. It’s going to be a post or a video.
- Josh Raghurai
 - “For the daily challenges like Victoria said it’s going to be posted in the morning and then we’ll just leave it till the end of the day and then at the end of the day or the next day, we will pick a winner and based on that we will give points to the individual personally or we aren’t necessarily doing teams this year. We will have an individual scoreboard and at the end of frosh, the person with the most points will win a prize such as New College merch. If you have any ideas of any type of challenges that correlate to Quarantine Dreams feel free to send them in. We will try to work them in and see if they apply to our situation.”
- Victoria Hanna
 - “Right now, we have like cooking challenges, trivia challenges or Tik Tok dance challenges. Anything you want to add let us know and we will add it.”
- Josh Raghurai
 - “On the first day we are doing a meet your council event, it’s where all of the froshies get to meet our council and we get to show them what we have to offer and show them the resources that we have available to us.”
- Victoria Hanna
 - “The meet your council is also going to be like an opening ceremony just to open up the week. For the York Campus Tour we are going to try and figure out some kind of video. We are still in the process of trying to figure out how we are going to do this.”
- Josh Raghurai
 - “The lounge chat is for in-between events when people either want a break or they just want to continue to hang out. This kind of resembles the lounge but on a zoom call until the next event. This would also be the place where they would meet up before an event and it is to give the froshies a place to just talk and get to know other froshies in between events.”

 - “We’re trying our best to resemble a sort of meeting place where they can just chill without having anything really scheduled.”
- Josh Raghurai
 - “We can add things and kind of direct the conversation but it’s not going to be an actual event.”
- Victoria Hanna
 - “We also have speed-friending, where we would just have everyone come on and do break out rooms so we can ask random questions for everyone to meet different people in these randomized groups. That’s it for day 1. For day 2, we have Zumba with York through Tait Rec and athletics. Then there’s a meet your major event which would be our sort of replacement for our clubs’ fair so usually, we have that event near the end of the week but since we can’t do that we are going to be doing more of groups where you can meet people whether you’re in accounting or marketing. We will be having a powerpoint to kind of guide the conversation and then hopefully we’ll get a leader or a captain to run through these power points.”
- Josh Raghurai
 - “When we break it down into different majors we will try and get an upper-year student so that they can answer most of the questions seeing as the first years will probably have a lot of questions.”
- Victoria Hanna
 - “After that we will have our lounge chat again and potentially our dance tutorial. If y’all have ideas for songs or dances, please let us know. That is followed by our virtual board game night such as taboo, jack box. This will occur in different break out rooms so you can jump between games as you wish.”
- Josh Raghurai
 - “On the Monday again, we post daily challenges. Then we have a website where there’s a volunteer to show the students how to enroll in courses, how to navigate the website, how to use a timetable.”
- Victoria Hanna



- “It’s essentially everything academic to the social aspect such as IMleagues. We were hoping to get academics to go through the academic portion and then potentially athletics to go through the social events. This event is not confirmed yet, but we are trying to do a social scavenger hunt type of thing. Where you guys are put into teams and there’s riddles and challenges that you must go through with your teammates. Then there’s the lounge again. After that there’s Nuit Blanche and Winters is hosting that. There’s going to be break out rooms for improv and things of that sort. For York Orientation Day we are still trying to figure that out with the Head of New College, so we don’t have too many updates on that. There’re some more challenges on the Wednesday, first year survival guide is kind of like a York 101. We will be trying to get YFS to come in, but we’ll see how that works out. That’ll lead us nicely into York Jeopardy. Which is then followed by Stong’s bingo night which is a college wide event.”
- Josh Raghurai
 - “Thursday there’s the daily challenge and then the health talk and wellness center. Leaders will get this talk during training and we thought it would be helpful for the froshies as well.”
- Victoria Hanna
 - “After that we will again have the lounge chat and then there’s a move-athon which is York’s replacement for the soccer tournament so there still trying to plan that out and all the colleges will be attending that. We might have a yoga session on the Friday morning and then there’s a treasure hunt.”
- Josh Raghurai
 - “It would be like what we kind of do in person for example first person to bring a pencil and show it on camera would get points. It would bring out people’s competitive nature which would facilitate more conversation and they would turn on their cameras.”

 - “We also wanted to add in an e tournament like FIFA or NBA, I know that York athletics are doing that so hopefully we can incorporate that as well. Strong is also going to do their pit party so we don’t exactly know what’s happening with that at the moment. After that, we are going to finish the week off with a talent show.”

- “We are going to be doing a Tory Lanez style talent show PG18 of course and I will be getting all the equipment, it’s going to be on Instagram live. Strong, Calumet, Founders and Vanier will be attending so it will be quite a large event which is why we chose to do it on Instagram live. We only ask that a couple of you come and participate as well as looking for froshies that are doing vulgar or rude.”

 - “After that we are ending the night with closing ceremonies. We will be having leader retreats August 8th and August 15th, council training will be August 24th in the morning, captain training will be August 24th in the afternoon and then August 25th, 26th and September 3rd everyone has to attend.”

 - “September 3rd is OTL, if you don’t know what OTL is, it’s the events where all colleges meet up and we do an overall training.”

 - “Just to finish off, we do need your help. Although this is not set in stone, we were thinking that Promo has already started decorating our schedule and they are trying to do an opening ceremony type of video. For athletics, we were thinking they could do something like Fifa or NBA tournament. The website walkthrough we said we were going to divide it between athletics and academics to show IMleagues and how to enroll in courses and stuff like that. Meet your major academics would do and we’d give you a rough template. For everyone else, we need daily challenge ideas and fun Jeopardy questions so you can send your ideas to us.”
