## President's Update

  - 1. Attended New College's audit meeting with Charmaine and VP Finance to discuss the financial position of the college throughout the years. Deficit is a big topic for this year and upcoming years that the council should focus on.
  - 2. Met with admin staff to update them on the missing terms. Requests for a change of locks for the back-office door and 104 door have been approved and will be done this week.
  - 3. Meeting with LAPS Clubs and presidents at the end of November to discuss our year and milestones.
  - 4. Remember everyone to please ensure to meet all the requirements of general members of the council and those specific to your position as that is what your honorarium will be based on. We do have a formula sheet that gives value to specific points so please ensure that if you want a full honorarium that you complete all of them.
  - 5. I worked on the NCC website and YU Connect. Requested event approvals for upcoming events (Niagara Trip and Case Competition) for advertisement on the platform but haven't heard back on an answer yet. YU Connect doesn't allow us to see membership yet, having a meeting in the last week of January and I hope that by then I can have good news so we can contact all constituents and increase participation.

## VP Finance Update

- Had a meeting with Charmaine about the following:
  - o Deficit.
  - Year End Audit completes 60% of levy will be received for the 2023-2024 year.
  - Currently doing 2024-2025 Interim Audit will finish by Jan 31<sup>st</sup>. 40% of 2024-2024 levy will be received.
  - One of the trips must be cut next year or formal (or formal must be much cheaper).
  - Along with Frosh must be cheaper by around 30k.
  - NC can make profit on events so forget about the myths you've been told.
  - Hold a little vote on whether you guys want little meetings for SIN (for honorariums above \$500).
    - Reason is because if NC is audited by CRA then us not having T4 documents could be an issue.
  - No updated currently on the stealing has called and filed a report with the police

I say we remove Niagara trip completely, which will provide a lot of leeway in the annual budget.
- 7. Lastly, we are looking at a new council position for case competitions within NC. Will elaborate in the meeting if I do not get stuck at work. (This Wednesday is a busy day).
  - Just in case, here are a few main points:
    - Make it a big conference in the First Student Centre (big rooms)
    - Have a council position under VP Academics who will mainly work on the conference & name them \*Conference Name\* Lead/Planner. – Must be a HIRED position.
    - By collaborating with all NC Clubs, we can have substantial turnouts and make revenue from delegate fees.
    - As we will be using the Second Student Centre as a venue there will be no substantial costs for running this big event.
    - Conference name somehow connect to NC/Eagles Strive Conference, Soar Conference, or something. Opinions?
