We will try to outline those seeing as you can't campaign in the lounge because it's closed"

We're either going to have it between nominating period and at the end it will be as long as you hand it in and have all 25 signatures, you're fine or we're going to have it right when the deadline is, it all depends."

 - "For this year, everyone has to either pick up their jerseys or we have to ship them. I think 8 or 9 people in total choose the shipping option for 7 of them it's cheap it's about \$15.50 for everybody because they are within Ontario. However, we do have 2 international students that have applied to be leaders and for their shipping it's about to be \$170 for one and \$190 for the other so as execs with the frosh team we wanted to subsidize for them because it's not fair to them to pay that much out of their own pocket. We wanted to let you all know this is what we are thinking of doing to make it fair so that the leaders can participate in frosh without paying such a big difference in shipping."

This allows for us to have flexibility in which platform is deemed most appropriate to use in each case to allow for each item to reach the most possible constituents.

 - "Just for standard in person elections what we usually do is we allow the candidate to put one poster in the lounge, they are able to post stuff on their story or Instagram and stuff like that however this year because everything is online they can't put stuff in the lounge so as I said before our Instagram, Facebook and Snapchat have become our lounge. For that, instead to give an even playing field for everyone, we will allow the candidate to post on their Instagram. That post will be their picture, their name and what they're running for and they'll give bullet points on why their running or what their goals are if they do get the position and everyone will post at the same time. Everyone will get a fair chance and that would replace the lounge poster. As well, we will be doing speeches so we will be doing Instagram live or on a zoom call and post them afterwards so if anyone did miss the speech, they can watch it after."

Motivation: As the election will be taking place online, all resources needed to campaign will likely be able to be found for free online. If a candidate wishes to be creative in some way they still do have the \$50 available to them, however since the bulk of expenses for campaigning with an online platform will be free, access to the \$50 per candidate will be reserved for cases where it is deemed necessary.

 - "If it was in person, spending the money would go to printing posters and stuff like that but again since everything is online posting on social media is free. We didn't think of any ways in which spending money would be deemed necessary but we also don't know what candidates are going to think of so we wanted to be open for them to still be able to spend some money however they will have to go through the CRO to get it approved in order to make sure the election process is fair."

Election times aren't really that big of a deal to switch so we're just passing this through the council, so it's acknowledged."

"We're debating on two ways for doing that. The CRO and I are thinking of doing it how we did our contracts with all of you and how we had you screenshare and sign the google document but instead of screensharing with everybody and recording that you would have to be on your Yorku account and we can check who edited what and from what user so if we see that it's that persons York u account they can put their student number down, their Yorku email and their signature we can see that and each candidate will have their own google doc. The second way we we're thinking was google form it's just the e-signature part that we're still figuring out for that to confirm that it was that person. As of right now, we are leaning towards the google document idea."
